## Note:

- A court order is not required under New York law to change your sex designation on an identity document (birth certificate, driver's license, photo ID, etc.) issued in New York.
- Every state has its own requirements for a sex designation change. Some states may not honor sex designation change orders from New York courts. If you want to change an identity document issued in another state, you should check that state's requirements before you file an application.
- This application is for a declaratory judgment. A declaratory judgment states a fact under the law. If granted, the sex designation change order legally recognizes your gender identity.

    - If you were born outside New York City, you can get a certified copy of your birth document from the New York State Department of Health's Vital Records Department
  - Certified Transcript of your Birth Certificate
  - Certificate from Commissioner or local Board of Health stating no such Certificate is available
